## **The rules: Pairing Rebates**

- Pairing rebates don't have to be on a single invoice and are aggregated during the period that they run
- The pairing must be sold to a single customer at one business location over the period the pairing is run
- Once the customer **hits the minimum**, they qualify on all purchases Example: 6 Interface and 200 Mirage, *all units get the rebate*
- End Users qualify on purchases from multiple distributors
- Example: 3 Interface & 1 Mirage from Dist A, and 3 Interface & 1 Mirage from Dist B qualify

# **2023 NOW/FALL Program Conditions**

- // Qualifying products must be ordered and invoiced by Agent/Distributor between August 1 December 4, 2023.
- // Qualifying purchases from August 1 October 31, 2023, may qualify for an additional 1% bonus. Purchases greater than \$39,249 are not eligible for the October bonus.
- # End-users must be registered in My Envu Rewards by December 31, 2023, and accept current Terms and Conditions.
- // All rebates for 2023 EOP will be paid in My Envu Rewards (MER) points, which can be redeemed for thousands of catalog items, Agent/Distributor credits and/or company checks. Checks will not be issued to a third party.
- // Rebates will only be paid to the company or name listed on the invoice.
- // Agency products purchased during the program period qualify for terms due June 7, 2024.
- // Rebates will be paid by July 31, 2024
- // Only end-user purchases qualify for this program, and purchases must be from a Envu authorized Distributor or Agent. Resale of product(s) purchased within this program will not qualify for rebates.
- // Altus rebate not available to production ornamental growers.
- // Volume discounts are applied at the individual invoice level. Multiple invoices will not be aggregated for price volume discounts.
- // Purchases of Specticle FLO during August 1 September 30, 2023, count toward achieving tiered rebates.
